1. CONTEXT OF GUIDELINES

This guideline is part of a package of regulations and guidelines which include:

- The Pakistan Environmental Ordinance 1997
- Policy and procedures for filing, review and approval of environmental assessments
- Guidelines for the preparation and review of Environmental Reports
- Guidelines for public participation
- Guidelines for sensitive and critical areas
- Pakistan environmental legislation and the National Environmental Quality Standards (NEQS)
- Sectoral guidelines for Environmental Reports

This guideline should not be read on its own, but in the context of the overall package.

2. PURPOSE

The objective of the guideline is to provide guidance to project proponents and other stakeholders in the environmental assessment process, so that the proposed projects are planned and sited in a way that protects the values of sensitive and critical areas.

These guidelines will help proponents of projects requiring Environmental Reports:

- in identifying what are the officially notified protected areas in Pakistan. These may include critical ecosystems including wildlife reserves and forests, archaeological sites, monuments, buildings, antiquities, or cultural heritage sites;
- if a proposed development is on a notified protected area or within the vicinity of such an area, then the approach detailed in this guideline should be adopted.

Sensitive ecosystems and archaeological sites and monuments are separately addressed, in Sections 4 and 5 respectively. Section 3 briefly discusses the formulation process of the guidelines and summarizes the important components of Sections 4 and 5.

The approach set out in this guideline will provide proponents and Review Authorities alike with a consistent and well defined process in facilitating decisions required to either prohibit or closely control development in protected areas.

3. BASIS OF THIS GUIDELINE

3.1 Principles

The guiding principles in developing these guidelines are:

- to help proponents identify "sensitive and critical" areas in Pakistan
- upon identification of proposed development in a "sensitive and critical area" the Responsible Authority will seek that the proponents, and the relevant conservation authorities have engaged in a verifiable process of communication with each other which leads to a thorough investigation of likely impacts and alternatives for the project; and satisfies the relevant conservation authorities requirements.

The formulation of these guidelines has involved visiting a number of government departments as well as non-government agencies. Some of the key contacts are listed at the end of Appendix III. The guidelines have been developed with extensive consultation with the relevant conservation authorities (listed as primary contacts in Appendix III).

In addition, numerous research materials have been collected and compiled in developing this guideline. The references provided in Section 7 refer to these.

Despite the extensive consultation with experts and research material, the guidelines have deliberately been kept simple; so that the process is clear and easy to follow for the proponent, and Review Authorities as well. By keeping the guidelines simple the both proponent and Review Authority will need to rely heavily on the relevant specialists such as conservation authorities to provide assistance on specific technical issues.

3.2 Protected Areas

Protected areas are of crucial and growing importance. This is because properly managed protected areas are based on the establishment of a system which aims to:

- safeguarding the earth's precious biodiversity
- protect outstanding areas of natural beauty, and
- conserve areas of cultural significance.

In Pakistan there exists a system of protected areas for the protection of endangered species, habitats, ecosystems, archaeological sites, monuments, buildings, and other cultural heritage.

The *threats* to protected areas in Pakistan are commercial-industrial pressures including mining, logging, development projects, and mismanaged tourism.

Protected areas in Pakistan can be broadly categorized into two groups; they are:

- 1. ecosystems, and
- 2. archaeological and cultural sites.

These guidelines apply for development related to protected areas (also referred to as sensitive and critical areas), and have been formulated for two parallel approaches, with almost identical processes. The two approaches have been developed for:

A. Ecosystems (includes protected areas such as wildlife reserves, national parks, game

reserves)

B. Archaeological Sites, Monuments, Buildings And Cultural Heritage (includes world heritage listing)

Protected area notification and management is the responsibility of two distinct authorities who manage the above respective areas. These authorities whether federal or provincial, and dealing with ecosystems or cultural heritage, are referred to in this guideline as "the relevant conservation authority".

Sections 4.5 and 5.4 provide the checklist of procedures for environmental assessment related to sensitive and critical areas.

3.2.1 Ecosystems

Protected areas help maintain the integrity and diversity of ecosystems, protect flora and fauna, and facilitate ecological processes such as water flows, soil regeneration, nutrient cycling and so on, which are vital for all life.

In Pakistan due to population pressures protected areas need to be managed with a sustainable balance of human populations. In our context the exclusion of human populations is not possible, and in fact could be non-humanitarian in some cases.

The balance between protection of species and meeting human needs is a delicate, and controversial issue which needs the careful consideration of the proponent, the relevant conservation authority, and the Review Authority.

The Secretary Forestry And Wildlife Department at the provincial level will be involved in the comment and recommendation for environmental assessments that are related to ecosystems. The proponent or consultant for a proposed development in a protected area will be required to contact the Secretary Forestry and Wildlife Departments in Punjab, Sindh, N.W.F.P, Balochistan, AJK, or Northern Areas.

At the federal level the office of the Inspector General Forestry (IGF) will be the central and national coordinator for the Provincial Wildlife Departments in the Environmental Assessment Report review. The IGF office has ongoing responsibilities for policy formulation, implementation, embedding process, monitoring, technical assistance, and R&D assistance if required. Finally, the IGF will need to be involved to assist in any dispute between the provincial wildlife departments and the proponent/consultant which they cannot resolve between themselves.

The Environmental Assessment Report should not be finalised and submitted to the Responsible Authority (i.e. provincial EPA's) until there is consultation with the provincial wildlife departments, and their comments and recommendations are taken into consideration as part of the mitigation and control measures.

These guidelines are expected to be included by the Federal IGF Office in the refinement of their current Forestry Master Plan for up to year 2017. The involvement of the provincial wildlife departments and Federal IGF in the Environmental Assessment Report review will become a critical part of the process for project review and approval, for development in or vicinity of protected ecosystems.

While the provincial wildlife conservation departments and the Federal IGF will provide this

technical and specialised expertise in the review process, the review of the environmental reports and the provision of any Environmental Approval will be undertaken by the responsible Authority, as provided for in the Act and elsewhere in the package.

3.2.2 Archaeological Sites and Monuments

The authorities to be consulted by the proponent are the provincial archaeological departments. In provinces where there is no government department of archaeology, there the Federal Director General Archaeology, will need to be consulted for developments related to archaeological sites, monuments, antiquities, cultural heritage, and world heritage listing sites. In provinces where there are archaeology departments the Federal Department of Archaeology will inform the provinces whether reference to them is necessary. Without this specialist input, comment and recommendations, the Environmental Report will not be acceptable to the EPA's for approval.

4. APPROACH TO ECOSYSTEMS

This section will deal specifically with critical ecosystems in Pakistan. In Pakistan there already exists an extensive list of officially notified protected ecosystems under various classifications. The approach taken in these guidelines is to concentrate on the protection of existing sites. While new sites will be notified through the provincial wildlife departments, it is also possible that a proponent or consultant may find a rare plant or animal species, or an important habitat, in a previously un-notified area. In such circumstances, the proponent or consultant should immediately notify the relevant conservation agency.

4.1 The Importance Of Protection

Human beings, habitat, and culture are dependent on resources which include:

- 1. soil
- 2. water
- 3. trees, other vegetation, and grasses
- 4. wildlife (including fish, insects, and other living organisms).

The above are key elements of an ecosystem and the survival of human beings depends on ecosystems. Wildlife is an expression of health of that ecosystem. Because wildlife is dependent on the same elements in the ecosystem as human beings it is therefor a vital link in the chain in the ecosystem to support human beings.

The vegetation in the ecosystem is what sustains the wildlife directly and indirectly. The vegetation in turn is dependent on soil, and water. The first three elements above conserve wildlife. Animals are attracted to a particular ecosystem because there exist a set of conditions in that environment that will nourish and shelter wildlife.

Thus wildlife is a component of the ecosystem whose health and well-being is safeguarded by the ecosystem. The wildlife in an ecosystem is in a way a report card on how well the first three major elements are being conserved as a means to protection of the ecosystem

The importance of protection of the notified protected areas of Pakistan stems from their particular value as an ecosystems with some specific biodiversity reserve. The biological diversity in a protected area is a precious natural resource which is essential to continued human existence. For example the principal food crops today were derived from wild species, and the

existence of genetic variability in the form of wild relatives of domestic crops is the source for continued improvement in yield and resistance to disease or stressful changes in environmental conditions.

Flora and fauna protection is necessary for the continued health of the environment we need to survive in. Healthy ecosystems provide the mechanism for the balance of nature. If we loose our flora, we will have uncontrolled erosion, less nitrogen fixing, more CO₂, and worse greenhouse, etc.

Wild plant and animal species are also of course sources of recreation and aesthetic pleasure; the responsibility for safeguarding the environment we share with them lies with us. In doing so we will act responsibly and leave a legacy behind for the generations to follow us. We have the opportunity today to modify previous patterns and take care of our common heritage.

4.2 Policies And Legislation

In addition to maintaining biodiversity the proponent needs to be aware of the various environmental legislation and regulations for Pakistan. The comprehensive list is presented in a separate guideline referred to as the "Pakistan environmental legislation and the national Environmental Quality Standards (NEQS)".

There is no central legislation for wildlife conservation in Pakistan. However, each province has its own laws covering protected areas. There are separate wildlife departments in the provinces that administer protected areas. For ecosystem protection the related legislation is listed in Table 1.

It should be noted the above legislation consists of complicated, lengthy, and legal documentation. Logically, only the relevant conservation authorities are in a position to provide the proponent or consultant with the most appropriate technical, scientific, administrative, and regulatory assistance relating to the different legislations.

4.3 Notified Protected Ecosystems In Pakistan

The Government of Pakistan in the past years has taken some concrete steps to preserve, conserve, and manage our national heritage; fauna and vegetation through the establishment of protected areas. This is being done through legislation, scientific research, and education. In all the four provinces there are statutes that provide for creation and management of National Parks, Wildlife Sanctuaries, and Game Reserves.

Although the present system of protected areas in Pakistan has a lot of room for improvement,

however the system has allowed large areas in a variety of Eco-types to be set aside for conservation. In the Wildlife Act of Punjab, declaration of Private Game Reserves over private lands has been provided for protection and management. There are reports¹ that such action by the State in the recent past has already started paying dividends; and increase in wildlife is visible.

A list of protected ecosystems of Pakistan can be obtained from the National Council for Conservation, or alternatively from the office of the Inspector General Forestry (IGF) Office. A provisional copy is provided as an attachment to this guideline, see Appendix I. This list is was updated in April 1997.

Up to date copies of this protected area list should be sought by the proponent to avoid confusion at any later stage in development; as it is an on-going process to bring new/critical ecosystem within official notification. For this reason contact with the relevant Provincial or Federal Forestry and Wildlife Department should be sought by the proponent early during the feasibility/conceptual stage of project development.

Table 2 provides an overall summary of the protected ecosystems in Pakistan which is based on the data on notified protected ecosystems in Appendix I.

4.4 Classification Of Ecosystems In Pakistan

The official classification of notified protected ecosystem in Pakistan consists of the categories already shown in Table 2. They include: Wildlife Sanctuaries, National Parks, and Game Reserves.

In addition there are protected forests, reserved forests, village forests/guzara forests, state forests, and range lands. The relevant conservation authority will supply information on these areas to the proponent or consultant.

4.4.1 Wildlife Sanctuary

The main features of a wildlife sanctuary include:

- undisturbed breeding ground
- prohibited or regulated public areas
- non-exploitation of forest.

The government rules pertaining to wildlife sanctuaries require either prohibition or control of the following variables:

- a) entry or residence,
- b) cultivate any land
- c) damage or destroy any vegetation,
- d) hunt, kill or capture any wild animal or fire any gun or other firearm within three miles of the boundaries or,
- e) introduce any domestic species of animal or plant,
- f) introduce any domestic animal or allow it to stray,
- g) cause any fir, or pollute water.

The level of control will vary for different reserves; the only logical contact to elaborate on this matter will be the relevant provincial forestry and wildlife department.

The Government may, by notification in the official gazette, declare any area to be a wildlife sanctuary and may demarcate it in a manner as it sees fit. The government may also for scientific purposes, aesthetic enjoyment, or for betterment of scenery authorize the doing away with the above mentioned regulations.

4.4.2 National Park

Some of the key features of the national park classification include:

- protection and preservation of scenery, flora and fauna in its natural state
- an area of outstanding scenic merit and natural interest.

The following acts are prohibited in a national park:

- a) hunting, shooting, trapping, killing or capturing of any wild animal in a national park or within three miles radius of its boundary;
- b) firing any gun or doing any other act which may disturb any animal or bird or doing any act which interferes with the breeding places;
- c) felling, tapping, burning or in any way damaging or destroying, taking, collecting or removing any plant or tree there-from;

- d) clearing or breaking up any land for cultivation, mining or for any other purpose;
- e) polluting water flowing in and through the national park:

Once an area is identified the specific rules pertaining to that area should be sought from the provincial forestry and wildlife department.

4.4.3 Game reserves

The Government may declare any area to be a game reserve where hunting and shooting of wild animals is not be allowed; expect under a special permit, which may specify the maximum number of animals or birds that may be killed or captured in the area and the duration for which such a permits will be valid.

4.5 Checklist Of Procedures For Environmental Assessment

In planning and siting a project the proponent needs to focus on being sensitive to the particular values of the relevant ecosystem.

Prior to any Environmental Approval being granted by the Responsible Authority, the following steps should be undertaken:

- 1. First of all the proponent should identify whether the site for the proposed development is within the precincts of a protected ecosystem. For this the proponent should refer to Appendix I. This list was last updated in April 1997. If the proposed site is not located in a notified area, and there are no apparent ecological or cultural values associated with the site, take no further action.
- 2. If the proponent, or consultant identifies an ecological site that appears to be of importance, but the site is not listed, they should discuss the site with the relevant conservation authority.
- 3. If the site falls within the boundaries of a protected ecosystem the relevant conservation authority in each province should be contacted for advice about the extent to which development may be allowed, and with what conditions (see Appendix III for contacts). Certain protected areas may have total prohibition of development while others may allow controlled development.
- 4. The relevant conservation authority should inform the Responsible Authority of their assessment of the significance of the likely impacts of the proposed development early in the process in order for the Responsible Authority to determine the level of documentation required. The Provincial EPA's will then be in a position to review the level of reporting required in light of the advice from the conservation authorities.
- 5. In the review of the Environmental Report, the Responsible Authority will liase with the Conservation Authority to ensure that impacts and mitigation measures detailed in the Environmental Report are well based, and to frame Environmental Approval conditions which protect the values of the listed area.

5. APPROACH TO ARCHAEOLOGICAL SITES AND MONUMENTS

5.1 The Importance of Protection

This section will deal specifically with archaeological sites, monuments, buildings, and cultural heritage sites in Pakistan.

In Pakistan there already exists an extensive list of officially notified protected archaeological sites and monuments under the Antiquities Act 1975. The approach taken in developing these guidelines is to concentrate on the protection of the existing sites. New sites may also be notified through the federal or provincial archaeology departments. If a proponent or consultant comes across an archaeological find he must immediately notify the department.

The proponent needs to be aware of the various environmental legislation and regulations for Pakistan. The comprehensive list is presented in a separate guideline referred to as the "Pakistan environmental legislation and the national Environmental Quality Standards (NEQS)". Archaeological sites and monuments are specifically protected by the Antiquities Act 1975.

5.2 Geological Sites In Pakistan

There are no officially notified or protected geological sites in Pakistan. However if there are any significant fossil finds during the course of development of a site the Federal Director General for the Museum of Natural History should be consulted.

5.3 Notified Archaeological Sites and Monuments

A list of protected archaeological sites, monuments, buildings and cultural heritage sites in Pakistan can be obtained from the Director General Federal Archaeology Department GOP. Appendix provides the current most up to date list.*

* This list is a 1996 Publication by the Pakistan Heritage Society Peshawar-Lahore and has been prepared by Mr. M. Rafique Mughal.

The Federal Department of Archaeology maintains a master register containing basic and vital information on the protected monuments and sites including full measurements of the protected area, description, location and Government Notification number with date of protection. The Central directorate general of Archaeology has a separate list which is continuously updated as and when new sites are declared as protected.

Since 1985, the Provincial governments have created their own departments of Archaeology and have been listing monuments as "Special Premises" in the Punjab and "Protected Heritage" in the Province of Sindh. The N.W.F.P government has not yet enacted laws governing archaeological and historical sites in the province, although they have created their own Department of Archaeology and are engaged in excavations of sites. Baluchistan does not have a department of archaeology.

In Pakistan at present there are 387 notified sites which are covered by Federal Antiquities Act (see Table 3). In addition Punjab government has some 200 notified sites. Karachi alone has over 200 buildings declared as "Protected Heritage" by the Government of Sindh.

Up to date copies of this protected area list should be sought by the proponent/consultant to avoid confusion at any later stage in development; as it is an on-going process to bring new sites within official notification. For this reason contact with the relevant Provincial or Federal Department of Archaeology should be sought by the proponent/consultant early during the feasibility/conceptual stage of project development.

Table 3 provides an overall summary of the protected antiquities under the Antiquities Act, 1975.

5.4 Checklist Of Procedures For Environmental Assessment

Prior to any Environmental Approval being granted by the Responsible Authority, the following steps should be undertaken:

- First of all the proponent should identify whether the site for the proposed development is within the precincts, or 200 feet, of a protected archaeological site or monument. For this the proponent should refer to Appendix II. If the proposed site is not located in a notified area, and there are no apparent archaeological values associated with the site, take no further action.
- 2. If the proponent, or consultant, identifies an archaeological site that appears to be of importance, but the site is not listed, they should discuss the site with the relevant conservation authority.
- 3. If the site falls within the boundaries of a protected archaeological site or monument, then depending on its classification the relevant conservation authority will determine the level of development allowable, and the applicable conditions (see Appendix III for contacts). Certain protected areas may have total prohibition of development while others may allow controlled development.
- 4. The relevant conservation authority should inform the Responsible Authority of their assessment of the significance of likely impacts of the proposed development early in the process in order for the Responsible Authority to determine the level of documentation required. The Provincial EPA's will then be in a position to review the level of reporting required in light of the advice from the archaeology department.
- 5. In the review of the Environmental Report, the Responsible Authority will liase with the relevant conservation authority to ensure that impacts and mitigation measures detailed in the Environmental Report are well based, and to frame Environmental Approval conditions which protect the values of the listed area.
