Pakistan Environmental Protection Agency, Islamabad invites applications/proposals from well reputed automobile workshops, firms based in Rawalpindi and Islamabad and registered with Income Tax and Sales Tax Departments, for their pre-qualification for the year 2023-24. Validity of submission of proposal for pre-qualification will expire on 30.6.2024 or till next prequalification/ tender interested firms/workshops may apply for Pre-qualifications by giving the details mentioned in application Performa with supporting documents. **Applications must be furnished separately for auto works, repair/ maintenance of machinery equipment and office building** to the office of undersigned in Pakistan Environmental Protection Agency Plot No # 42, Street No # 6, H-8/2, Islamabad on or before 30-11-2023 at 1:30 hrs. The applications for prequalification will be opened on same day at 14:00 hrs. in the presence of applicants or their representatives, if like to be present. In case any information provided in the application is found incorrect, the applicant will render himself liable to disqualification from registration. Pak-EPA reserves the right to accept or reject any or all applications for Pre-qualifications on the basis of assessment criteria as per PPRA Rules 2004 and amendments made time to time. The decision of Pak-EPA as to whether or not the applicant/ firm is eligible for Pre-qualifications shall be final and binding on all the applicants/ firms. The application Performa for Pre-Qualification along with detail terms and conditions can be downloaded from official website www.environment.gov.pk of Pak-EPA, Islamabad or can be obtained from the office of Assistant Director (Admn/Finance), Pak-EPA, Islamabad.

The proposal for pre-qualification must be submitted separately for each automobile workshops, firms for miscellaneous repair maintenance works of office building, machinery/ equipment and exhibition/ seminars etc. The sealed envelope must be **mentioned nature & type of proposal** (i.e. automobile works/ miscellaneous repair/ maintenance work of office building of machinery equipment/ seminars etc.) Tender shall be valid upto **30.6.2024** till next tender from the date of acceptance and firms/dealers will have to submit a call deposit in the shape of Demand Draft of **Rs.20,000/-** to DDO, Pak-EPA, Islamabad along with their Tenders.

All reputable and well established Automobile workshops/ firms are invited to apply for the Pre-qualification by submitting the Pre-Qualification proposal Performa.

Pak-EPA, Islamabad will process all the procurements in accordance with the policy defined and specified under PPRA Rules by the Government of Pakistan.

- g. Details of employees of the firm (Permanent, Temporary, Technical and non-Technical) with designation and contract numbers.
- h. Annual Turnover supported by Income Tax returns.
- i. Previous detail of works with documentary proof.

**TERMS AND CONDITIONS FOR THE PRE-QUALIFICATIONS OF AUTO
WORKSHOPS/ FIRMS**

1. The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached.)
2. The firm should have proper workshop & office setup at Rawalpindi/Islamabad.
3. The auto workshop & firm must be manned with experienced Toyota, Suzuki, Hyundai, Kia, & other company's vehicles mechanics, technicians and workers with at least one relatively higher qualified & experienced person preferably heading the team of mechanics/technicians at the workshop/ firm.
4. The firm/ workshop must be equipped with the modern gadgetry and equipment for maintenance, repairs (minor and major), servicing and tune-up of vehicles as well as office machinery equipment/ lab equipment of all models and makes.
5. The firm/ workshop must have provision of preventive /routine maintenance including all preventive checks and oil change, brake pads, battery inspection, gear and hydraulic oil level, tune-up, wheel balancing, wheel alignment & other repair/ maintenance work, etc.
6. The workshop must have readily available spares, lubricants and consumables, field mechanic services and vehicle-towing facility to be made available on request whenever necessary.
7. The firms related to repair/ maintenance of office machinery equipment should have sufficient skills, knowledge, expertise and worth for smooth carrying out the repair maintenance works.
8. A certificate shall be given by the each competing firm that he will be responsible for the free replacement of items if the same are found to be substandard.
9. All parts should be qualitative, new and in original manufacturers packing.
10. **In case of stores of imported origin:-**
 - A certificate should be given by the bidders that the spare parts / stores shall be genuine, brand new and in the original packing of the manufacture.
 - A certificate should be given by the bidders that he will be responsible for free replacement of item / parts if not found suitable for the engine, machinery or its ancillary equipment or demand.
 - Manufacturers' name, in whose packing the stores will be offered for inspection must be given in the offer.
11. The pre-qualified firms would be required to submit Security Deposit in the shape of CDR for RS.20,000/- (Rupees twenty thousand only) in favor of DDO, Pak-EPA and in case of failure, the firm will be treated as non-prequalified. The security will be released to the firms within 30 days after expiry of the period of Pre-qualification. Cash/Cheque and less amount of security deposit will not be accepted.
12. The firms for pre-qualification for seminars, workshops, exhibition etc. must provide complete detail of their previously organized events.
13. For maintenance of office building, the firms should provide their final worth.

14. Each prequalified workshop/ firm performance in terms of quality, delivery, after sales service, maintenance/ repairs, credit terms and other contractual obligations will be closely monitored and periodically reviewed during the contractual period.
15. The proposal /application shall be submitted in sealed envelope marked as under on front corner:
 - i. Proposal for auto workshop.
 - ii. Proposal for repair/ maintenance of machinery/ equipment & hardware.
 - iii. Proposal for conducting seminar/ work shop, exhibition.
 - iv. Repair/ maintenance of Laboratory equipment.
 - v. Repair/ maintenance of Office Building etc.
16. The envelopes shall also bear the word “CONFIDENTIAL” and above identifications
17. If the envelope is not marked, as instructed above, the Pak-EPA, Islamabad will assume no responsibility for the misplacement or premature opening of the documents.
18. The applications should reach this office before or by 30-11-2023
19. The proposals should not have any over-writing or cutting. The application(s) with any of the aforementioned defects may not be considered.
